Introduction

Peace and conflict studies is a relatively new field that grew out of the devastating violence of the First World War and gained traction in academia in the decades following World War II. President Woodrow Wilson's Fourteen Points for peacemaking in 1918 laid out many of the same principles for peace that are still accepted by peace scholars to this day, such as disarmament and free trade. With the end of the Second World War and the creation of the United Nations, it became evident to scholars that in order for the United Nations to maintain its mission of promoting international cooperation and peace, rigorous research needed to be done in the areas of peace and conflict resolution.

In 1948, Manchester University in Indiana created the first undergraduate academic program in peace studies in the United States. Similar programs and related courses became more widespread throughout the 1960s due to the Vietnam War and the desire of anti-war undergraduate students to pursue peaceful solutions to violent conflicts. By the 1980s, as the prospect of nuclear apocalypse seemed almost imminent, the number of peace studies courses available at universities worldwide increased dramatically. With the end of the Cold War, peace and conflict studies remained widespread throughout university curricula, but the focus shifted from pre-Cold War emphasis on international conflict to a more comprehensive focus on peace and conflict as it relates to the human condition with a growth in interest related to human rights, gender inequality, human security, democratization, as well as the more traditional aspects related to security issues and conflicts.

While peace and conflict studies grew in academic curricula, peace-related research institutes were founded. The Peace Research Institute Oslo (PRIO) was the first to be created in 1959 and with it, the creation of the first peace and conflict-focused journal: the *Journal of Peace Research*. Many other peace research centers were created, such as the Peace Science Society (which publishes the journals *Journal of Conflict Resolution* and *Conflict Management and Peace Science*), the International Peace Research Association, and the Peace and Justice Studies Association (which publishes the journal *Peace and Change: A Journal of Peace Research*), just to name a few.

Peace and conflict studies encompasses a variety of disciplines including international relations, political science, philosophy, gender studies, religious studies, economics, geography, history, anthropology, and psychology. It is also multicultural and examines conflict and relationships at all levels, from interpersonal to international in scope. Researchers apply both theoretical and empirical methods to analyze conflicts and propose peaceful resolutions, while also examining issues related to human rights, marginalization, and ecological degradation, with the goal of promoting sustainable world peace.

This topic is of interest to scholars and laypeople alike and as such, there is a variety of literature available for all levels of expertise. From grassroots organization newsletters to peer-reviewed scholarly articles written by leading experts in the field, there is no shortage of resources for peace and conflict studies and the publications highlighted in this section represent the top resources on this spectrum. These resources provide the latest insights and research in the multifaceted area of peace and conflict studies for researchers, activists, scholars, and policy makers.

The Arms Control Association, which publishes *Arms Control Today*, was founded in 1971 and is a national nonpartisan membership organization dedicated to promoting public understanding and support for arms control policies. It helps provide policy makers, the press, and the public with authoritative information, analysis, and commentary on arms control proposals, treaties, negotiations, agreements, and other national security-related issues. This magazine is dedicated to promoting a better understanding of arms control subjects and offers comprehensive data and intelligence on national security issues. Each issue begins with a "Focus" essay that highlights an important issue related to arms control: for instance, an article in the latest issue talks about "Freezing and Reversing North Korea's Nuclear Advances." Other feature articles include "Papal Condemnation of Nuclear Deterrence and What Is Next," and "Improving U.S. Ballistic Missile Defense Policy." Interviews with important decision makers in the arms control arena are also conducted and well documented in the Q&A section, such as the article "Ambassador Adam Bugajski: 'The NPT is still strong and alive,' in which Poland's permanent representative to the U.N. office discusses the Nonproliferation Treaty. The "News" section has articles such as "Chemical Attack Kills Dozens in Douma" and "Denuclearization Poses Summit Challenge." A bibliography with citations to current literature on topics relevant to the subject being discussed is found in each issue. This is an excellent resource for academic libraries and research centers.

Founded by a former physicist who worked on the Manhattan Project, the *Bulletin of the Atomic Scientists* aims to increase the public's interest in regard to atomic energy and its risks. Since 1945, the *Bulletin* has stuck to its mission of educating citizens about the dangers of nuclear weapons, and in 1947, the *Bulletin* created the Doomsday Clock, which has become the universal symbol of the various threats to humanity, including weapons of mass destruction, climate change, and other disruptive technologies. Featured articles cover such topics as climate change and rising sea levels, nuclear proliferation, and cybersecurity. The "Nuclear Notebook" column has been published since 1987 and provides an overview of a different country's nuclear capabilities. In the "Global Forum" section of a recent issue, there is an article "Ban the bomb by... banning the bomb?" in which authors from three countries, Joelen Pretorius of South Africa, Polina Sinovets of Ukraine, and Mustafa Kibaroglu of Turkey, discuss what aspects the prospective U.N. treaty that would outright ban nuclear weapons should include and debate whether such a treaty would actually speed up the disarmament process. Issues often have a theme that shapes the content. Recent themes include "The wages of climate inaction: Ever-rising seas," "Resilience and the climate threat," and "How dangerous is hybrid war?" The *Bulletin* provides refereed articles about nuclear weapons, global security issues, and threats to humanity that are written in an accessible manner for the general public, policy makers, scientists, scholars, and journalists.

Conflict Management and Peace Science is a peer-reviewed journal published in association with the Peace Science Society (International) at Pennsylvania State University. It contains scientific papers on topics such as international conflict, arms races, the effect of international trade on political interactions, foreign policy decision making, international mediation, and game theoretic approaches to conflict and cooperation. A current issue includes articles such as "Anger, legacies of violence, and group conflict: An experiment in post-riot Acre, Israel" and "Economic sanctions and the dynamics of terrorist campaigns." This journal occasionally has special issues with all the articles focused on a particular topic. Previous special issue topics include "Gendered participation, well-being, and representations in political violence" and "Managing territorial conflict." These articles are primarily written for a scholarly audience and would be most useful in academic and research library collections.

Fellowship is the oldest continuously published multi-faith, multi-cultural peace journal in the United States. Published quarterly by the Fellowship of Reconciliation since 1935, it follows its predecessor, *The World Tomorrow*, which began in 1918. *Fellowship* publishes analytical insights, spiritual visions, and personal journeys to aid people of all faiths commit themselves to a nonviolent world of justice, peace, and freedom. A recent issue features articles such as "This is an Uprising: How Nonviolent Revolt is Shaping the Twenty-First Century" and "Christianity is Not the Enemy." In addition to articles on both current and historical events, *Fellowship* also provides interviews, poems, and news briefs to round out its thoughtful approach to encourage conflict resolution through peaceful efforts by all individuals. This publication would be useful in both public and academic libraries.

International Journal on World Peace is an academic journal that has multidisciplinary articles that focus on all aspects of peace. This journal was founded by scholars gathered in Virginia for a Professors World Peace Academy Conference in 1983 and began its quarterly publication with the September 1984 issue. Its editorial board consists of members from 17 countries such as France, Sri Lanka, Russia, Kenya, New Zealand, the United States, and the Czech Republic. Recent articles include "Moving from reactive to proactive

Islam," "Just war theory: North Korea and the United States," and "Religion, NGOs, and the United Nations: visible and invisible actors in power." In addition to refereed articles written by international scholars with diverse backgrounds and specialties, this journal also includes a news section and book reviews. While scholarly in nature, the content would appeal to patrons at both academic and public libraries.

Founded in 1994, *International Peacekeeping* was the first scholarly journal to focus on examining peacekeeping activities following the end of the Cold War. This international peer-reviewed journal examines the theory, practice, outcomes, and consequences of peacekeeping operations throughout the world. With an expansive scope, this journal provides analysis and debates regarding peacebuilding and monitoring activities, humanitarian intervention, preventative deployments, sanctions, international policing, and the complex relationships between peacekeepers, civilians, NGOs, rival factions, and state authorities. Articles from a recent issue include "Social Capital Made Explicit: The Role of Norms, Networks, and Trust in Reintegrating Ex-combatants and Peacebuilding in Liberia," "The Spatial Concentration of Peacekeeping Personnel and Public Health During Intrastate Conflicts," and "Information Processing Challenges in Peacekeeping Operations: A Case Study on Peacekeeping Information Collection Efforts in Mali." Articles provide coherent and timely analysis on topics such as the causes and prevention of war; U.S.-China relations; ethnic conflict and internal war; terrorism and insurgency; Asian, European, and regional security; U.S. foreign and defense policy; nuclear proliferation; international relations theory; diplomatic and military history; and cybersecurity. Peace Magazine is published by the Canadian Disarmament Information Service, a group committed to educating the public on all aspects of peace. Published quarterly, this magazine consists of articles, news stories, interviews, reviews of films and books, and letters. Their online site also includes a weekly video stream from the magazine's editor called "Talk about saving the world." The magazine's focus includes peace, disarmament, human rights abuses, weapons of mass destruction, conflict resolution, and political or military affairs. Authors include scholars, journalists, and activists. Articles are written in an approachable manner and can be easily understood by laypersons. This magazine is available both online and in print, but full content is not always available online until after the publication year has ended. This is a good magazine for high school libraries, as well as public and academic libraries.

Published twice a year, this journal focuses on issues of conflict, violence, disarmament, poverty, just peace, and human well-being, with an emphasis toward encouraging peaceful methods for conflict resolution. Articles from the most recent issue include "The Legacy of Colonialism Among Indigenous Peoples: Destructive Outcomes, Healing and Reconciliatory Potentials," "'Deviously Ingenious': British Colonialism in Jamaica," and "The Three Rs: Resistance, Resilience, and Reconciliation in Canada and Ireland." Introduction

Articles concerning health, wellness, nutrition, care, welfare, behavior, communication, grooming, training, advocacy and rescue, and the human-animal bond, as well as heartwarming stories of actual animals, are commonly featured in many of the magazines in this section.

Most pet magazines, such as *The Bark*, *Catster Magazine*, *Reptiles*, and *Tropical Fish Hobbyist*, focus exclusively on either dogs, cats, reptiles, or fish. *Pets Magazine*, however, contains articles on both cats and dogs.

During the past several years, there has been an increase in the number of titles that publish articles on natural care, nutrition, and holistic medicine. The focus of *Animal Wellness Magazine* and *The Whole Dog Journal* is on natural health care. Other publications provide medical information for pet owners. The Cummings School of Veterinary Medicine at Tufts University publishes *Camp and Your Dog*, and the Cornell University College of Veterinary Medicine publishes *CatWatch* and *DogWatch*, which are newsletters that provide medical, health, and behavioral information on cats and dogs.

Titles that are part lifestyle magazine and part pet publication continue to be popular. Many of these magazines, such as *The Bark*, *Fido Friendly*, *Modern Cat*, and *Modern Dog*, contain articles on fashion, travel, and social and activism issues, as well as profiles of and interviews with celebrity pet owners.

Many of the publications noted in this section actively engage their readers using social media and Facebook. Most have web sites where visitors can locate subscription information, scan the tables of contents, and view photographs of the covers of the current issues. Other sites are more extensive and allow visitors to read selected articles from current and previous issues, participate in online forums, and pose questions to veterinarians and other pet experts.
